

Bulletin for project Website re consultation process during Covid 19 restrictions

"In accordance with the requirements of national guidelines for infrastructure projects, the first phase of the N25 Waterford to Glenmore project has been completed and confirms the project's strategic fit with current policies and programmes and has identified the need for the scheme and its objectives.

Within the study area for the project, a broad range of constraints and features have been identified which could influence the identification and assessment of viable scheme options.

We are now in a position to engage with the public and present the finding of the constraints study and to seek feedback on the scheme options that have been identified as part of Phase 2 – Option Selection.

However, in accordance with the current Covid-19 restrictions and advice, all face to face public consultations and meetings have been postponed until further notice.

Given that the Covid 19 restrictions are continuing, albeit easing, we are seeking the public's engagement in the form of an on-line consultations which is accessible through the project website, in combination with information in local newspapers. This consultation has been arranged to take place on-line and by post from the 2nd to the 5th of June and to invite submissions up until the 26th June. The consultation is currently being advertised on the project website now and in local newspapers circulating in the scheme area from the 2nd to the 3rd of June.

From the 8th of June onwards, we will continue to address any project queries by phone or email via the contact details provided on the 'Contact Us' page of the website.

It is intended that once covid-19 restrictions are lifted a public display event will be arranged to present the findings of the constraints study and the identified route corridor options, and to seek the public's feedback. Notification of this public display event will be advertised on this website and on local media and relevant information will also be uploaded to the project website in advance.

The project team will also continue to perform their duties, but no key project decisions that require input or feedback from the public will proceed until we are in a position to engage directly through public consultation."

Bullaitín do Láithreán Gréasáin tionscadail maidir leis an bpróiseas comhairliúcháin i rith shrianta Covid 19

"I gcomhréir le riachtanais treoirlínte náisiúnta do thionscadail bhonneagair, críochnaíodh an chéad chéim de thionscadal an N25 ó Phort Láirge go dtí an Gleann Mór agus deimhnítear go n-oireann an tionscadal i dtaobh cúrsáí straitéiseacha de do bheartais agus cláir reatha agus sainaithníodh an gá atá leis an scéim agus a cuspóirí.

Sainaithníodh réimse fairsing shrianta agus gnéithe laistigh den limistéar staidéir don tionscadal a d'fhéadfadh tionchar a imirt ar roghanna inmharthana scéime a shainaithint agus a mheasúnú.

Is féidir linn idirchaidreamh a dhéanamh anois leis an bpobal agus torthaí an staidéir ar na shrianta a chur i láthair agus chun aiseolas a lorg ar roghanna na scéime a sainaithníodh mar chuid de Chéim 2 – Roghnú na Rogha.

I gcomhréir le shrianta agus comhairle reatha Covid-19, áfach, cuireadh gach comhairliúchán agus cruinníú poiblí aghaidh ar aghaidh siar go dtí go bhfógrófar a mhalaírt.

Nuair a chuirtear san áireamh go leanann shrianta Covid 19 a bheith i bhfeidhm, cé go bhfuil laghdú ag teacht orthu, lorgaímid go nglacann an pobal páirt i bhfoirm comhairliúcháin ar líne a bheidh ar fáil trí láithreán gréasáin an tionscadail, anuas ar eolas i nuachtán áitiúla. Eagraíodh go mbeidh an comhairliúchán seo ar siúl ar líne agus sa phost ón 2 go dtí an 5 Meitheamh agus is féidir aighneachtaí a sheoladh ar aghaidh go dtí an 26 Meitheamh. Tá comhairliúchán á fhógaírt faoi láthair ar láithreán

gréasáin an tionscadail agus i nuachtáin áitiúla atá á scaipeadh i limistéar na scéime ón 2 go dtí an 3 Meitheamh.

Más mian leat labhairt le ball fairne den tionscadal faoi cheist ar leith, is féidir leat é sin a dhéanamh trí ghlaobh ar 01 8108000 idir 09:00 agus 17:00 uair ón 2 go dtí an 5 Meitheamh.

Ón 8 Meitheamh ar aghaidh, leanfaimid ag dul i ngleic le haon cheisteanna faoin tionscadal ar an nguthán nó ar ríomhphost trí na sonraí teagmhála a chuirtear ar fáil ar an leathanach ‘Teagháil a Dhéanamh Linn’ den láithreán gréasáin.

Beartaítear, a luaithe a bhaintear srianta Covid-19, go socrófar imeacht taispeána poiblí chun torthaí an staidéir ar na srianta agus roghanna chonair an bhealaigh a sainaithníodh a chur i láthair, agus chun aiseolas an phobail a lorg. Fógrófar an t-imeacht taispeána poiblí seo ar an láithreán gréasáin seo agus sna meáin áitiúla agus déanfar an t-eolas ábhartha a uaslódáil go dtí láithreán gréasáin an tionscadail roimh ré freisin.

Leanfaidh foireann an tionscadail ag tabhairt faoina ndualgais freisin, ach ní leanfar ar aghaidh le haon phríomhchinntí tionscadail a dhéanamh óna dteastaíonn ionchur nó aiseolas ón bpobal go dtí gur féidir linn idirchaidreamh díreach a dhéanamh trí chomhairliúchán poiblí.”
